Nowadays, criminal acts are not only committed by adults but also by minors. This happened at the Jambi City Resort Police. However, the resolution of this case was not through punishment but by using restorative justice by means of diversion. What is the diversion policy for perpetrators of criminal acts committed by children in the jurisdiction of the Jambi City Police Department? crimes committed by children in the jurisdiction of the Jambi City Police Department. The research method used is in this research an empirical juridical type with a socio-legal research approach, then the data sources used are field research and library research so that the data collection techniques are interviews and documentation. So the data analysis technique is descriptive qualitative. The diversion policy for perpetrators of criminal acts committed by children in the Jambi City Resort Police jurisdiction is guided by Law Number 11 of 2012 concerning the Juvenile Criminal Justice System by prioritizing the interests of children in conflict with the law, seeking to carry out the diversion process using restorative justice. In carrying out the diversion policy against perpetrators of criminal acts committed by children in the Jambi City Resort Police Jurisdiction, namely factors that make it difficult for both parties to carry out diversion, factors that the victim wants the case to proceed to the realm of law and factors that the community does not participate, efforts to overcome obstacles in implementing the diversion policy towards perpetrators of criminal acts committed by children in the Jambi City Resort Police Jurisdiction, namely providing understanding to each party, both regarding the process and purpose of carrying out diversion and providing outreach on a deeper understanding of diversion to the victim's family and the community in an objective manner.
