

## ABSTRAK

Analisis Putusan Hakim Pengadilan Negeri Surabaya Terhadap Vonis Bebas Gregorius Ronald Tannur, Studi Kasus Putusan Nomor: 454/Pid.B/2024/PN.Sby. Penelitian ini mengenai tentang vonis bebas yang diberikan oleh hakim pengadilan negeri surabaya terhadap Terdakwa Tindak Pidana pembunuhan Gregorius Ronald Tannur terhadap Korban Dini Sera. Metode penelitian yang digunakan dalam penelitian ini adalah metode penelitian yuridis normatis dengan menggunakan pendekatan Perundang-Undangan, Pendekatan Konsep, dan Pendekatan Kasus. Hasil Penelitian yang diperoleh antara lain: (1) Berdasarkan putusan hakim, hakim menimbang bahwasannya Terdakwa Gregorius Ronald Tannur dianggap tidak secara sah meyakinkan bersalah telah melakukan tindak pidana berdasarkan dakwaan Jaksa Penuntut Umum, karena Hakim menimbang bahwa Korban Meninggal karena kelalaian Terdakwa dimana hal tersebut tidak meyakinkan hakim bahwa Terdakwa telah menghilangkan nyawa Korban Dini Sera. (2) Pada putusan Nomor: 454/Pid.B/2024/PN.Sby tidak sesuai dengan Peraturan Perundang-Undangan khususnya yang menyangkut tentang Undang-Undang Nomor 48 Tahun 2009 tentang kekuasaan kehakiman dimana disebutkan bahwa dalam memutuskan suatu perkara hendaklah hakim memberikan putusan atas nilai keadilan yang berdasarkan kepada ketuhanan yang maha esa dan putusan tersebut tidak memberikan nilai keadilan bagi pihak Korban.

## ***ABSTRACT***

Syakirah Dieva Nanda F 2100874201123. “Analysis of the Decision of the Surabaya District Court Judge Against the Acquittal of Gregorius Ronald Tannur, Case Study of Decision Number: 454/Pid.B/2024/PN.Sby.”

This research is about the acquittal given by the judge of the Surabaya District Court against the defendant of the crime of murder Gregorius Ronald Tannur against the victim Dini Sera.

The research method used in this research is normative juridical research method using Legislation approach, Concept Approach, and Case Approach. The results of the research obtained include: (1) Based on the judge's decision, the judge considered that the Defendant Gregorius Ronald Tannur was deemed not legally convincing guilty of committing a criminal offense based on the charges of the Public Prosecutor, because the Judge considered that the Victim died due to the negligence of the Defendant, which did not convince the judge that the Defendant had taken the life of the Victim Dini Sera. (2) Decision Number: 454/Pid.B/2024/PN.Sby is not in accordance with the Laws and Regulations specifically concerning Law Number 48 of 2009 concerning judicial power which states that in deciding a case, the judge should give a decision on the value of justice based on the almighty God and the decision does not provide justice for the victim.
