Meskipun pada dasarnya adalah hak antara narapidana wanita dan narapidana pria adalah sama, hanya dalam hal ini karena narapidananya adalah wanita maka ada beberapa hak yang mendapat perlakuan khusus dari narapidana pria yang berbeda dalam beberapa hal, diantaranya karena wanita mempunyai kodrat yang tidak dimiliki oleh narapidana pria yang menstruasi, hamil, melahirkan, dan menyusui maka dalam hal ini hak-hak narapidana wanita perlu mendapat perhatian khusus baik menurut Undang-Undang maupun oleh petugas Rutan. Penelitian ini memiliki tujuan mengetahui bentuk perlindungan hukum terhadap narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi, hambatan dalam memberikan perlindungan hukum terhadap hak-hak narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi, upaya dalam mengatasi hambatan dalam memberikan perlindungan hukum terhadap hak-hak narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi. Penelitian ini termasuk penelitian yuridis empiris. Hasil penelitiannya ialah bentuk perlindungan hukum terhadap narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi yaitu hak mendapatkan makanan yang layak, pelayanan kesehatan, perawatan jasmani, rohani, pendidikan dan pengajaran dan hak menyampaikan keluhan. Hambatan dalam memberikan perlindungan hukum terhadap hak-hak narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi yaitu terbatasnya sarana dan prasarana, kurangnya tenaga ahli dan pendanaan. Upaya dalam mengatasi hambatan dalam memberikan perlindungan hukum terhadap hak-hak narapidana wanita di Lembaga Pemasyarakatan Perempuan Kelas IIB Jambi yaitu dalam pemenuhan sarana dan prasarana pihak lapas menyediakan ruangan khusus di blok yang berbeda dari narapidana laki-laki agar memang benar-benar terpisah, serta memasarkan hasil keterampilan/kerajinan tangan narapidana agar dapat membeli kebutuhan keterampilan itu kembali.

Although basically the rights of female prisoners and male prisoners are the same, only in this case because the prisoners are women, there are several rights that receive special treatment from male prisoners which are different in several ways, including because women have natures that male prisoners do not have. menstruating, pregnant, giving birth and breastfeeding, in this case the rights of female prisoners need to receive special attention both according to the law and by detention officers. This research aims to determine the form of legal protection for female prisoners at the Class IIB Jambi Women's Penitentiary, obstacles in providing legal protection for the rights of female prisoners at the Class IIB Jambi Women's Penitentiary, efforts to overcome obstacles in providing legal protection for their rights. female inmates at the Class IIB Jambi Women's Penitentiary. This research includes empirical juridical research. The results of his research are forms of legal protection for female prisoners at the Class IIB Jambi Women's Penitentiary, namely the right to receive adequate food, the right to health services, the right to receive physical and spiritual care, the right to receive education and teaching and the right to submit complaints. Obstacles in providing legal protection for the rights of female prisoners in the Jambi Class IIB Women's Penitentiary are limited facilities and infrastructure, lack of expert staff and funding. Efforts to overcome obstacles in providing legal protection for the rights of female prisoners in the Jambi Class IIB Women's Penitentiary, namely in providing facilities and infrastructure, the prison provides special rooms in different blocks from male prisoners so that they are truly separate, as well as marketing the results of skills. /handicrafts for prisoners so they can buy the skills they need back. The prison authorities are trying to carry out regeneration in the prisoners themselves. Due to the lack of funding for this training, we are doing as much as possible so that the results of their skills can be used as capital to provide all the equipment needed for these skills and with this regeneration, of course it will save money. the cost of the training itself.
